

**United States Bankruptcy Court Eastern District of Pennsylvania

It has long been the practice in the United States Bankruptcy Court for the Eastern District of Pennsylvania that an original hearing on any motion presenting a contested matter is an **evidentiary hearing**. See e.g., L.B.F. 9014-3. “Unless the court orders otherwise, hearing on contested matter will be an evidentiary hearing.” (emphasis on *original* hearing).

Settlements or requests for continuances should be reported to the Courtroom Deputy by 5:00 p.m. **the day before** the scheduled hearing date.

To obtain a hearing date for a Motion to Extend Stay, Motion to Approve a Disclosure Statement, motions in Adversary Proceedings, or for any hearing estimated to last a total of 30 mins or more -- contact the Courtroom Deputy 215-408-2839 for scheduling.

(As required by rule, notice must be filed no later than two business days following motion)

If a party wishes to schedule a hearing on a date different from the dates set forth above, Judge Baker will consider a matter set on “regular notice” provided the motion and notice of hearing are filed a minimum 22 days in advance of the hearing date (except for matters otherwise governed by Fed. R. Bankr. P. 2002(b), 3007(a) or LBR 9014-2). Notices of hearing, and service of motions, are governed by the Federal Rules of Bankruptcy Procedure and all local rules.

It is the responsibility of the filer to ensure proper notice and service.

The party must choose a hearing date that complies with these time requirements.
