Dispositive Motions: The Local Motion Practice Rules apply to dispositive motions in adversary proceedings including motions for judgment on the pleadings, motions to dismiss and motions for summary judgment. However, in preparing and serving the Notice of Motion, Counsel should not assign a hearing date. You may leave that line blank or write “not applicable.” A hearing date, if needed, will be assigned by the Judge.
