

Philadelphia Hearing Dates for the Honorable Patricia M. Mayer

All requests for continuances and notices of settlement **must** be reported to Judge Mayer's Courtroom deputy **at least 24 hours prior** to the hearing on the matter. If a settlement or continuance is not timely reported, counsel must appear at the scheduled hearing.

The following schedule is for use from **July 17, 2026, to July 24, 2026, ONLY**

11 U.S.C. § 362(e) requires a hearing on motions for relief from stay filed pursuant to § 362(d) within 30 days of filing. Any Motions for Relief from stay filed pursuant to 11 U.S.C. § 362(d) scheduled beyond the 30-day hearing requirement will be DEEMED to have WAIVED the 30 days hearing requirement.

All motions to extend the stay filed pursuant to 11 U.S.C. § 362 (c)(3) must be filed and heard within 30 days of filing. If a hearing date is not available within the 30-day period, counsel must file the appropriate motion for expedited hearing to ensure compliance with 11 U.S.C. § 362(c)(3)(B).
