Annualized Salary ranges from \$81,474 (JSP 11/1) to \$150,962 (JSP 13/10).
Starting salary commensurate with qualifications and legal work experience.

POSITION OVERVIEW

Full time, not to exceed two years, term law clerk position with a possibility of renewal. Provides legal research and writing assistance to the Judge. Reviews pending matters on the judge's court calendar. Prepares bench memos, draft orders and opinions, communicates with counsel regarding case management and procedural requirements, and assists the Judge during courtroom proceedings. Performs other duties as assigned by the Judge.

QUALIFICATIONS

For consideration, candidates must be law school graduates from an ABA accredited law school with excellent academic credentials. It is preferred that applicants took bankruptcy in law school or have experience in the bankruptcy field or comparable practice areas, such as a prior clerkship. Law review or law journal experience preferred. Applicants must be highly skilled in legal research and writing, and must be able to use Westlaw, Lexis, Word, Outlook, PowerPoint, or comparable products. Familiarity with electronic case filing and management systems such as NextGen CM/ECF and CHAP is preferred. Applicants must be able to process and resolve complex issues. Excellent verbal, written, and interpersonal skills, maturity, judgment and discretion are required.

EMPLOYEE BENEFITS

Compensation will be set based upon the experience and qualifications of the successful candidate subject to the policies and guidelines set forth in the Judicial Salary Plan. Law clerks can qualify for participation in pre-tax benefit programs (health, dental, and vision insurance coverage, flexible spending accounts, commuter reimbursement); group life insurance, and eleven paid holidays per year.
