## Reading, PA Hearing Dates for the Honorable Patricia M. Mayer

All requests for continuances and notices of settlement **must** be reported to Judge Mayer's Courtroom deputy **at least 24 hours prior** to the hearing on the matter. If a settlement or continuance is not timely reported, counsel must appear at the scheduled hearing.

The following schedule is for use from July 11, 2025, to July 18, 2025, ONLY

11 U.S.C. § 362(e) requires a hearing on motions for relief from stay filed pursuant to § 362(d) within 30 days of filing. Any Motions for Relief from stay filed pursuant to 11 U.S.C. § 362(d) scheduled beyond the 30-day hearing requirement will be DEEMED to have WAIVED the 30 days hearing requirement.

All motions to extend the stay filed pursuant to 11 U.S.C.§ 362 (c)(3) must be filed and heard within 30 days of filing. If a hearing date is not available within the 30-day period, counsel must file the appropriate motion for expedited hearing to ensure compliance with 11 U.S.C. § 362(c)(3)(B).
