

## Reading, PA Hearing Dates for the Honorable Patricia M. Mayer

All requests for continuances and notices of settlement **must** be reported to Judge Mayer's Courtroom deputy **at least 24 hours prior** to the hearing on the matter. If a settlement or continuance is not timely reported, counsel must appear at the scheduled hearing.
